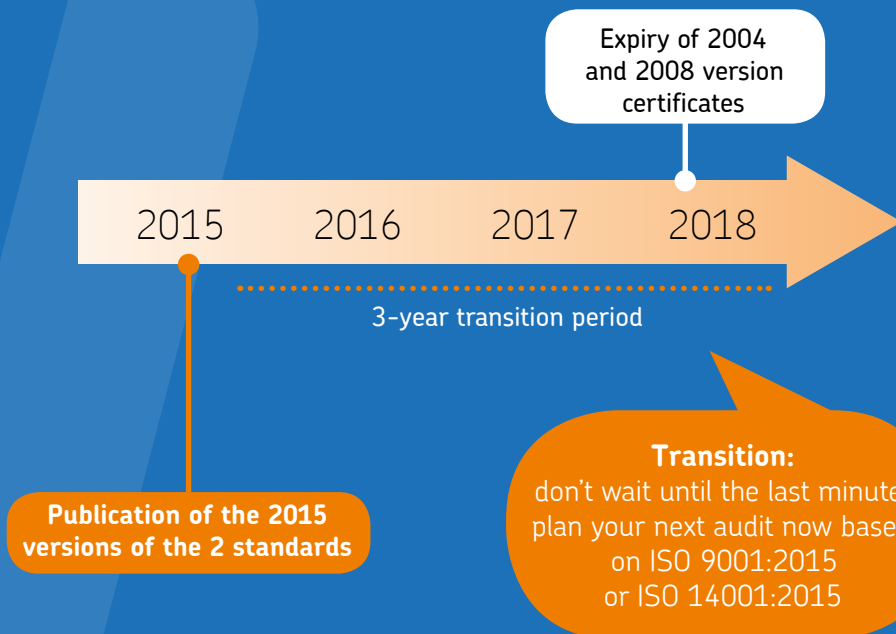
## PREPARE FOR CERTIFICATION

# The new-generation standards foster an entrepreneurial spirit

- Alignment of the management system with **the enterprise's strategy**.
- Control of the entire **value chain** (suppliers, subcontractors, etc.), or life cycle analysis (ISO 14001).
- **Measuring and improving performance**.
- **Making document management less burdensome**.
- Adoption of a common structure for management systems (**60% common requirements** - a great incentive to integrate other management systems).
